ADDEDUM TO SUBPOENA TO MDEQ

DEFINITIONS

1. For purposes of this subpoena, "the Michigan Department of Environmental Quality (MDEQ)" means the department and any of its employees at any time from January 1, 2011 to date.
2. For purposes of this subpoena, "documents" means writings, e-mails and text messages along with any attachments, electronically stored documents, hard copy documents, photos, videos and audio recordings.
3. For purposes of this subpoena, "KWA" means the Karegnondi Water Authority.

Subpoenaed Documents

1. Produce all documents sent to or received by MDEQ from any source regarding Flint water as a drinking water source, Flint River water quality, Flint water system, and KWA from January 1, 2011 the present.
2. Produce all documents generated by MDEQ regarding Flint water as a drinking water source, Flint River water quality, Flint water system, and KWA from January 1, 2011 to the present.
